

DISCLOSURE REGARDING PROGRAM PREPARATION FOR PROFESSIONAL LICENSURE OR CERTIFICATION

The University of Louisiana at Lafayette is committed to providing clear and accurate information to current and prospective students to help inform career planning. The UL Lafayette program identified above prepares students to practice in a field with professional licensure or certification available. However, specific licensure and certification requirements can and often do vary by state. Requirements typically include earning a degree or other educational credential in the field from an institution and program that meet certain eligibility requirements in that state (e.g., curricular requirements, accredited status, approval by the state licensing board); passing a state or national exam; working in the field for a minimum period of time; and/or completing a certain number of clinical hours. If your career plans include pursuing professional licensure or certification in your chosen field, it is important to become educated on the credentialing requirements of the state in which you hope to practice.

UL Lafayette Program Preparation in the State of Louisiana

Individuals and firms shall not perform or offer to perform architectural services, either directly or indirectly, unless they have secured a license to practice architecture from the Louisiana State Board of Architectural Examiners. Additionally, no person shall use the title "architect" or any derivation of that word unless they have secured a license to practice.

Requirements set by the National Council of Architectural Registration Boards and the Louisiana State Board of Architectural Examiners for **Architect** include:

- National Architectural Accreditation Board (NAAB) Accredited Degree
- Completing the Architectural Experience Program (AXP)
- Completing the Architect Registration Examination (ARE)
- Gaining membership to the Louisiana State Board of Architectural Examiners (LSBAE)

UL Lafayette Program Preparation in Other U.S. States

The Master of Architecture Program at UL Lafayette is a NAAB accredited degree. Individuals completing this program are eligible for licensure or certification in additional states and should defer to individual state licensing boards for any alternate or additional requirements.
